PROPERTY DESCRIPTION

Associated Appraisers of Walla Walla, LLC is pleased to present the offer for sale a property located north of Prescott in Walla Walla County.

This farm is located about three miles north of Prescott along both sides of Skyrocket Road, it has a total of **986.97 acres** of which **764.36 acres are tillable**.

Access to the tract is along Skyrocket Road, a gravel surfaced county-maintained road, that runs from the southeast corner, northwest through the central area of the tract; and from Marr Road, a gravel surfaced county-maintained road that runs east/west through the northern area. The irregular shaped tract is rolling to steep in topography with elevations ranging from about 1,565 feet up to about 1,940 feet above sea level. Annual rainfall is about 14 to 16 inches. Power is available to the property. The historic winter wheat yield is 83 bushels per acre on a winter wheat/summer fallow rotation.




Facing North along the Eastern Boundary of the Northern Area of the Tract

Facing Southeast along Skyrocket Road Near the Northwest Boundary of the Tract




Walla Walla County Aerial Parcel Map




Soils

PARCEL A:

Beginning at the Southwest corner of the Southeast quarter of said Section 9, and running thence North, along the North and South centerline of said Section 9, a distance of 1770 feet to the center of the County Road; thence following the County Road North 82° 30' East 260 feet; thence South 84° 30' East 150 feet; thence South 48° 30' East 473 feet; thence South 35° 00' East 283 feet; thence South 19° 00' East 883 feet; thence South 16° 00' West 427 feet to the South line of said Section 9; thence leaving the County Road, West 1105 feet to the point of beginning.
